

## **Bonus Points**

This documentation is a list of 950 bonus points claimed with documentation and a list of stations worked for Field Day 2014 by the Five Flags Amateur Radio Association in Pensacola, Florida.

#### Emergency Power – 400 points

- 1. Two HF stations was set up in Escambia Search and Rescue Emergency Command Center.
- 2. Two HF stations was set up in the Dewey's Motor Home.
- 3. Both RV's has their own built in generator that was run during Field Day to provide all electrical power needed for everything inside the RV.



#### Set-up in Public Place (100 points)

- Field Day location this year was the parking lot of the Sherriff's Warrington Sub-Station on Navy Blvd, next to the Warrington Fire Dept. This location is on a major road in Escambia County within a short distance to the main gate of Naval Air Station Pensacola.

#### Public Information Table (100 points)
